



**Minutes of the ordinary meeting of the Rowney Green Association  
Held on Tuesday 6<sup>th</sup> July 2021**

**1. Minutes of last meeting**

The status from May was approved as written.

**2. Matters arising**

All are covered in the agenda.

**3. Treasurer's report**

There is £1,871.31 in the bank and £124.76 cash in hand. This reflects a £50 contribution towards the village lockdown memorial book. It was agreed at the meeting to make a £100 contribution towards the publication of the Calling Oak village magazine.

**4. Membership**

It was confirmed that 122 out of 195 houses in the village are members of the RGA, with 59 subscriptions outstanding following Covid restrictions on collections. It was agreed to restart the collection of membership subscriptions falling due in 2020/1 after 19<sup>th</sup> July 2021. MC will send out patch status to all collectors with bank details. All payments this year will provide three year's membership starting from January 2021. A proposal to revise payment to £5/year by Direct Debit was discussed favourably which would need to be ratified at the AGM in September.

**5. Planning Update**

The Bordesley Hall planning application is being submitted for approval in August. There had been a significant number of objections raised by the village.

APC believe enforcement action is still in progress on the Dell development and have requested an update from BDC planning.

Planning requests have been submitted for new houses on waste land near the Hopwood roundabout and on Ash Lane.

There is a planned closure on Rowney Green Lane on 22/7/2021 for two days to allow Severn Trent to carry out work. Signage is in place.

**6. Crime issues**

Neighbourhood Watch has been very quiet since the last meeting. The Wythall group has been disbanded as it was felt that neither the police, nor residents were showing much interest.

**7. Council issues**

Aled Luckman, the newly elected councillor has agreed to meet the RGA Chair at a date to be confirmed.

**8. A.O.B.**

It was agreed to hold the RGA AGM on 1<sup>st</sup> September in the Village Hall main room. All positions are available for election and new applicants would be warmly welcomed.

The AGM will be advertised in the Calling Oak, Village Hall notice board and via the village WhatsApp.
